## **DECLARING MAY 2025 AS MENTAL HEALTH AWARENESS** AND TRAUMA-INFORMED CARE MONTH

WHEREAS, mental health is essential to overall well-being, and everyone experiences times of stress and adversity, and;

WHEREAS, one in four adults and one in five youth ages 13 to 18 experience mental health challenges, and;

WHEREAS, 60% of adults and 50% of youth do not receive the mental health treatment necessary due to limited knowledge of the need, barriers to care, fear or shame, and;

WHEREAS, adverse childhood experiences (ACEs), which include physical, emotional and sexual abuse or neglect, household dysfunction, untreated mental illness, untreated substance misuse, separation or incarceration of a household member and domestic violence, are traumatic experiences that can have a profound effect on a child's developing brain and body and can result in poor health during childhood and adulthood, and;

WHEREAS, studies show that the effects of ACEs are felt regardless of age, race, ethnicity, religion, gender, sexual orientation or socio-economic status, and;

WHEREAS, isolation, sickness, grief, home instability and community trauma increase the need for mental health services, and;

WHEREAS, mental wellness leads to higher productivity, better educational outcomes, lower crime, stronger economies, lower health care costs, and improved quality of life, and;

WHEREAS, creating safe, stable, nurturing relationships and environments helps to prevent adverse experiences and creates positive childhood experiences, helping children achieve their full potential, and;

WHEREAS, each business, school, government agency, health care provider, faith-based organization, nonprofit agency and citizen has a responsibility to promote mental wellness, and;

WHEREAS, the Palm Beach County Board of County Commissioners recognizes "Get Your Green On," celebrating 10 years as a countywide campaign that encourages mental health care and trauma-informed approaches through the systems of care.
